## Photo Competition of the Shipping Deputy Ministry

**Subject : «Cyprus: The Shipping Star of the Mediterranean»**

### 1. Scope of the Competition

The Shipping Deputy Ministry of the Republic of Cyprus, in cooperation with the Cyprus Marine Club and the support of the Cyprus Photographic Society, are launching a photo competition with subject : *Cyprus: The Shipping Star of the Mediterranean*. The competition will be held from 26/11/2018 to 11/01/2019.

- All images should be relating with merchant shipping and / or the Cyprus Maritime tradition.
- The purpose of the competition is to raise public awareness regarding Cyprus shipping and to attract public interest regarding the Cypriot maritime tradition. Furthermore, the competition aims to enrich the archive of the Shipping Deputy Ministry with unique and innovative images for its upcoming promotional campaigns.
- Participants will be able to submit both colour and/or black and white images.
- Participants are allowed to submit up to five (5) images, but only one prize would be awarded to each participant.
- Photos should be submitted in high resolution electronic format.
- Participants are required to submit the Participation form (Annex I) together with the images. In the case of submitting more than one images then each image must be numbered.
- Participants should be aware that by submitting their images in the competition, they consent to the possible use of their photos by the Shipping Deputy Ministry at its promotional material such as : exhibitions, website, booklets, posters and other promotional activities indefinitely.
- Photos that have been awarded in previous competitions or have already been publicly posted will not be accepted for this competition.

**2. Condition of entry:** all persons entering the Competition must be over 18 years old. Images should be the original work of the entrant. Participation in the competition is free of charge.

**3. Prohibition from the Competition:** The employees of the Shipping Deputy Ministry of the Republic of Cyprus and their relatives up to the second degree.

**4. Duration of the Competition** is defined as the period from 26 November 2018 to 11 January 2019 at 23:59. Any entries submitted after the expiration of the Competition will be automatically rejected.



**5. Submissions:** Participants must submit their entries accompanied by the participation form (annex I) within the above timeframe, at the following email address: [maritimecyprus@gmail.com](mailto:maritimecyprus@gmail.com)

**6.** After the deadline for submissions, all images received will be forwarded to the evaluation committee. A photo exhibition will follow presenting the winners' images and a series of other selected images which took part in the competition.

**7.** The photographs will be judged by a 5-Member Evaluation Committee comprising 2 representatives from the Shipping Deputy Ministry of the Republic of Cyprus, 2 representatives of the Cyprus Marine Club and 1 representative of the Cyprus Photographic Society. The decision of the Evaluation Committee is final and irrevocable.

### **8. Prizes**

The following 3 prizes will be awarded:

- 1st Prize – 500 euro plus an engraved glass trophy
- 2nd Prize – 250 euro plus an engraved glass trophy
- 3rd Prize – 125 euro plus an engraved glass trophy

The evaluation committee reserves the right to replace prizes with other gifts of equal value at its reasonable discretion.

The awards are sponsored by **Fleet Management Limited**, Nicosia and **ÖL Shipping Group**, Limassol.

**9. Announcement of the results and awards of the prizes.** The Shipping Deputy Ministry will inform the winners by email. Emails will not be sent to any participants not receiving a prize. The winners as well as their images will be posted at the official website of the Shipping Deputy Ministry. The award ceremony will take place during the official reception of the Shipping Deputy Ministry on 4 February 2019 which will be combined with the aforementioned photo exhibition. The photo exhibition will be open on 4 and 5 February 2019.

**10. Responsibility.** The Shipping Deputy Ministry is not liable for any delays occurred during the submissions due to technical reasons. The Shipping Deputy Ministry has no responsibility if, for reasons outside of its sphere of influence and control, the submission of entries fails or is delayed, or, finally, if the records kept from it are destroyed, partially or totally.

**11. Personal Data** Acceptance of the terms hereof as well as the actual participation in the competition, imply the explicit and unconditional consent of the participants to the Shipping Deputy Ministry to proceed, in its reasonable judgment and solely for the purposes of the present competition, to the announcement of the participation and publicity of the images of the participants.

Participation in this Competition automatically implies the consent and assignment of the necessary copyrights to the Shipping Deputy Ministry of the Republic of Cyprus. The Participants with their participation provide the Shipping Deputy Ministry of the Republic of Cyprus, with their consent and permission in accordance with the provisions of Law N 125 (i) / 2018, on the

Protection of Natural Persons with regard to the Processing of Personal Data and for the Free Movement of such Data, for the notification of their participation in the competition.

In addition, the participants expressly consent to the Shipping Deputy Ministry of the Republic of Cyprus to forward the above information only to person who, upon the instructions and on behalf of the Shipping Deputy Ministry of the Republic of Cyprus, may be involved in the selection of the winners of the competition and the award of the prize to them.

## **12. Special Terms of Tender - Copyright**

It is expressly stated that the submitted images should not violate provisions of the law, be offensive, unethical and unrelated to the matter. The image must not contain or refer to third party trademarks. If the participants decide to send pictures that distinguish the persons included, they should have obtained the consent of the person or guardian in case of a minor. **Images with content of people who clearly distinguish their face and are not accompanied by their written consent will be disregarded.**

**Each participant expressly consents to the use of his name and image by the Shipping Deputy Ministry in the framework of this competition and for the promotion of the Cyprus Shipping.**

**13. Withdrawal of a Call - Modification of Terms.** The Shipping Deputy Ministry reserves the right to change the present terms of the contest, to shorten or to extend its duration, or to withdraw it, by informing the participants in advance through the official website of the Shipping Deputy Ministry.

**14. Terms acceptance the terms.** Participation in this competition means unconditional acceptance of these terms of participation as a whole.
